Dear Ms. Yang,

My name is LE CORRE Vincent B [REDACTED] and I am a citizen from the European Union currently residing in Taiyuan, Shanxi.

I am the owner of the Twitter account @ECtHRwatch

I've sent you some direct messages via Twitter. In this email, I am sending you scans from 4 different IDs to prove my identity to you.

Your webpage listed on GitHub states you are a tech correspondent. My story is not related to the tech field.

It also states you are Vice-President of the Foreign Correspondents' Community of China.

I have a story to tell. I am not completely ready yet. I need to prepare more documents which I have to publish online.

I am glad to see that you believe "there are excellent and exceptional journalists and publications who investigate and expose".

My father-in-law, [REDACTED]  
[REDACTED] He said once that as a journalist in China, it's possible to write anything you want. But if the story is sensitive, it will never be published.

For the story I have to tell to be published, I need a breakthrough. For the last year, I've started to increasingly think harder and harder how to get the right approach. In the last 6 months, I believe I've already got 2 non negligible developments.

I would very much like to meet some journalists face to face in Beijing to talk about this story. Maybe not right now because there is the coronavirus crisis, but maybe in a few months when the situation improves.

I believe this story will never be published without a Court ruling. I hope I can be successful in obtaining a favorable ruling before the European Court of Human Rights. It's not easy to obtain. But my evidence are very strong : doctoring of legal public documents by French magistrates and/or clerks of French courts. It's very serious. It's a crime under French law.

It's a long story. It's a good story.

Please forgive me in advance if I sometimes sound... well... like... if I don't express myself very smoothly. English is not my mother tongue.

On top of this, I am often feel tense when I think about this story. All of what has happened so far. My fear, sometimes, that I could be arrested. Why would I be arrested? There are no reasons for me to be arrested, I am law-abiding person.

But you know... when legal documents are being doctored, the consequence of which is the exoneration of a multinational corporation which I accuse of fraud and money laundering, well yes... sometimes, I am scared. Sometimes, I wonder what kind of influence they hold.

Journalists are my best friends figuratively speaking. That's why I hope I could meet many journalists. I am willing to take the train to Beijing when it's safer to do so. I believe the more I talk to journalists, the more I publish documents online, the safer I will be.
